Join the Timperley Villa Lottery and help support your local community club

Timperley Villa Youth Football Club is a volunteer organisation providing football for children ranging from under U7's through to U18's. Our aim is to provide high quality sport and an enjoyable environment for all local children. We do this by keeping our membership subscription as low as possible, approximately £3 per week per child. For this we provide:

- Entry in to league & cup competitions for all teams U9s upwards
- Tournament entry to JJB for our U7s and U8s and summer competitions for our junior sides
- 22 weeks training on the UK's finest floodlit, all weather pitch at BTH for all teams U9's upwards
- All weather training facilities, year round at South Trafford College, for our U7s & U8s
- Use of St Hugh's School, Timperley Rec, Beech Fields and other local pitches for matches
- Training by FA qualified coaches for all teams; training for our junior teams supervised by UEFA qualified coaches, including coaches working for local Premiership and professional league clubs
- Provision of kit, balls, and training equipment.

When you look at it its very good value for £3 per week! However in order to move the Club forward and provide the same level of facilities we desperately need to generate more income and it is our desire to do this without having a significant impact on membership fees.

As a result we are introducing the Timperley Villa lottery. At the end of every month (Sept – June) we will draw 3 numbers and payout cash prizes to the winners. 40% of the money raised each month will be paid out as prize money.

The lottery is not only open to Timperley Villa members; all family, friends and other members of the community are welcome to join in.

The profits will go to maintaining and developing the facilities and enjoyment factor that the children have when they play football at Timperley Villa and provide them with a sense of belonging in the community.

We can collect your payments by standing order (form overleaf) so you don't have to worry about remembering to pay and you will automatically be entered into the draw every month. Alternatively you can pay for the period up-front by cash or cheque (payable to Timperley Villa YFC). If paying by cheque or cash please complete the tear off section at the bottom of the standing order mandate, but not the mandate itself.

Every £1 counts so please give generously.

TV Lotto - The official Lottery of Timperley Villa Youth FC

1. These Terms and Conditions are the Lottery Rules. By entering the lottery, entrants (lottery members) agree to be bound by these rules.
2. This lottery is being promoted by and on behalf of the Timperley Villa Youth Football club (TVYFC).
3. For the purpose of the Gambling Act 2005, this lottery is defined as a 'Society Lottery.'
4. This lottery is registered under the 2005 Gambling Act, and is promoted by Timperley Villa YFC.
5. To enter the lottery, you must be a UK resident aged 16 (sixteen) or over.
6. There will be 3 guaranteed monthly winners. Prize money will be 40% of the monthly income up to a total monthly maximum of £400. Maximum monthly prizes are 1st £250, 2nd £100, 3rd £50.
7. All tickets shall be priced at £1.00; minimum purchase is 2no. tickets.
8. All lottery entry sales are final and no refunds shall be made at any time. All entrants acknowledge that their payment of £1.00 per ticket to enter the lottery does not guarantee that they will win any prize.
9. The draw for the prizes will be made monthly. You do not need to be present at the draw to win the lottery.
10. If a cash prize is awarded, this will be made by cheque in the name of the entrant only.
11. Full payment for each ticket must be received in the form of cleared funds before the ticket can be entered into the draw. Only tickets for which full payment has been received are eligible to win a prize.
12. The winners of the lottery prizes will be notified by email. Results will be published on TVYFC website.
13. All entrants are solely responsible for providing TVYFC with their accurate and up-to-date contact details and TVYFC will be in no way liable for any failure or inability to contact any entrant due to any errors, omissions or inaccuracies in the contact details that the entrant has provided. In the event that an entrant changes their contact details, they will be solely responsible for advising TVYFC of the change.
14. By accepting the prize, the winner agrees to take part in promotional activity and TVYFC reserves the right to use the name of the winner, their photograph and audio and/or visual recordings of them in any publicity unless prior notification has been received.
15. Each game number is unique. A randomly selected game number will be issued with the confirmation of entry. Any member may subsequently request an alternative game number if they wish at any time and this will be issued providing that it has not already been allocated to an existing member.
16. Lottery membership can be cancelled at any time by notifying TVYFC in writing, by phone or via email.
17. TVYFC shall not be liable to the member for any loss or damage suffered or arising from:-
 - any delays or failures in the postal service or other delivery methods used by TVYFC or the member from time to time.
 - any delays or failures in any software or other systems used by TVYFC for the administration of the lottery.
 - any delays or failures in the Banking system used by TVYFC or the member.
 - any refusal by TVYFC to accept registration of an individual as a member or the cancellation of a member.
 - any failure to enter a chance into the draw.
 - any event beyond the reasonable control of TVYFC
18. Nothing within these terms and conditions shall create or should be construed as creating any form of contract between any entrant and TVYFC.
19. Any complaints relating to the lottery should be sent in writing to TVYFC, c/o CSS Regal Buildings, 2 Marsland Rd, Sale, M33 3HQ, giving full details of the complaint and supporting documentation.
20. TVYFC is committed to protecting the member's privacy. Data that is collected from the lottery member is used lawfully in accordance with the Data Protection Act 1998 and is used solely for the purpose of administering the lottery, processing lottery chances, subsequent entry into the lottery draw, and informing winners that they have won a prize.
21. Any lottery member has the right to access the information held about them. To obtain this information, please contact the Club Secretary.
22. TVYFC will not sell, rent or grant access of any personal data of any lottery member to any third party without express prior permission.
23. In the event of any dispute regarding the rules, the decision of TVYFC shall be final and no correspondence or discussion shall be entered into.
24. TVYFC reserves the right to amend these rules at any time. If TVYFC does this, it will publish the amended rules.
25. TVYFC reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of these rules.
26. Each entrant should retain a copy of these Terms and Conditions for their reference.
27. This lottery is a form of gambling. Participants are encouraged to gamble sensibly.
28. The Laws of Great Britain shall govern the interpretation and/or enforcement of these Terms and Conditions and TVYFC and all entrants hereby submit to the exclusive jurisdiction of the English Courts.
